

CONTEST “My parents and ME, what a team!”

CONTEST RULES

1. Duration of contest

The contest is organized by the Fédération des caisses Desjardins du Québec. It begins on September 8, 2008, and ends on March 27, 2009.

2. Description of prizes

The prizes will consist of 38 family vacation packages worth \$700 each, two per regional division, and 15 “I save for my dream!” certificates worth \$100, awarded among the participants. 19 winter vacation packages (e.g. skiing, mountain resorts, etc.) will be awarded in December 2008ⁱ. 19 summer vacation packages (e.g. parks, water parks, zoos, museums, etc.) and the 15 “I save for my dream!” certificates worth \$100 will be awarded in April 2009.

Parents who accompany their child(ren) will be able to choose between several destinations across Québec and some locations in Ontario.

Each family vacation package includes accommodations and one or more tourist, cultural or outdoor activities.

All expenses other than those indicated above, namely, the cost of transportation from the winner's residence to the chosen destination and any personal expenses, are not included in the prize and shall be covered by the winners.

3. How to participate

To become eligible to win one of the family vacation packages, one of the parents or guardians of the young member of the Desjardins School Caisse must duly complete the Contest Registration Form “**My parents and ME, what a team!**” and indicate:

- his or her name, address and telephone number;
- the name of his or her child (the school caisse member), the child's birthdate, grade and the name of the child's school;
- the number of the child's school caisse folio and the name of the Desjardins caisse.

To be eligible for the 15 “I save for my dream!” certificates draw, the parent must have completed, with his or her child, the section that describes the child's dream.

4. Selection of winners

Winners will be selected by a random draw among the registration forms for the contest “**My parents and ME, what a team!**”ⁱⁱ received between September 8, 2008, and March 27, 2009.

Random draws will be held on:

- December 4, 2008, for the first draw of vacation packages worth \$700;
- April 9, 2009, for the second draw of vacation packages worth \$700 and the draw for 15 “I save for my dream!” certificates worth \$100 each.

ⁱ Winners of the December 2008 draw will be awarded the summer vacation package of their choice.

ⁱⁱ The contest registration form “My parents and ME, what a team!” completed by the child and his or her parents has no legal value. The 15 “I save for my dream” \$100 certificates will be deposited in cash into the child's school caisse account. The child does not have to fulfil the dream described in his or her registration form.

IN ORDER TO PARTICIPATE IN ALL THREE DRAWS, REGISTRATION FORMS MUST BE RECEIVED BY THE CAISSE NO LATER THAN NOVEMBER 21, 2008. FORMS RECEIVED AFTER THIS DATE AND NO LATER THAN MARCH 27, 2009, WILL BE ELIGIBLE FOR ONLY THE APRIL 2009 DRAWS.

A person may not win more than once.

Before being declared winners, the selected contestants must have correctly answered the mathematical skill-testing question that appears on the Contest Registration Form "My parents and ME, what a team!"

The contest organizers will telephone the selected contestants to give them information on their prize and how to obtain it. The announcement for the first draw will be made during the week of December 15, 2008; the second and Third draws will be announced during the week of April 20, 2009.

5. Eligibility

The contest is open exclusively to the members of the school caisses located within the territory of the caisses populaires of the Fédération des caisses Desjardins du Québec and the Fédération des caisses populaires de l'Ontario, as well as their parents. The children of employees of Desjardins Group or one of its constituents may not enter this contest. Verifications will be made prior to the official announcement of the winners.

6. General

Prizes must be accepted as awarded and cannot be exchanged, substituted for another prize or transferred to a third party. The contest organizers' decision to this effect is final and cannot be appealed. Winners release the contest organizers from any liability in terms of any loss or damage that could arise from accepting and using the prize.

By participating in this contest, all winners authorize the organizers to post their name on the Desjardins Internet site.

The winners consent to Desjardins Group or one of its constituents using their name for promotional purposes without additional compensation.

The contest participants acknowledge having read the contest rules and agree to comply with them.

The Fédération des caisses Desjardins du Québec reserves the right to terminate this contest if events beyond its control prevent it from continuing and cannot be held responsible in such a case.
