- **2 positions for the Ottawa Region:** includes the territory of the City of Ottawa and the counties of Lanark and Renfrew as well as part of the county of Prescott and Russell
- **1 position for the Sudbury and Northern Ontario Region:** includes the territory between the southern border of Nipissing and Parry Sound Districts, the Quebec border and the Manitoba border
- **1 position for the Toronto and Southwestern Ontario Region:** includes the territory between the eastern boundary of Lennox and Addington County, the United States border to the south and the northern boundary of Muskoka, Haliburton and Hastings Districts
