Blended benchmark rebalanced periodically to reflect a decreasing risk tolerance

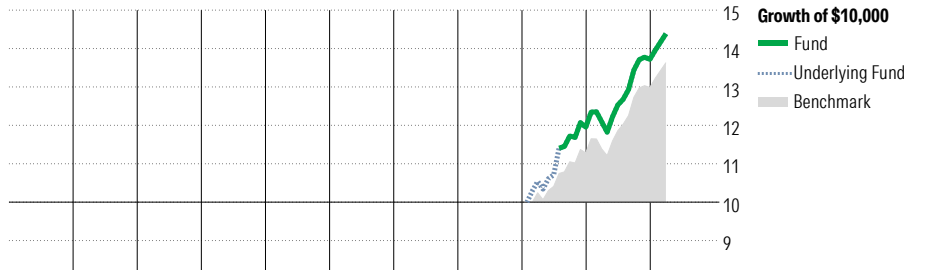
Investment Strategy

The fund is intended for investors who had or are planning to begin drawing income from their savings between 2033 and 2037. Over time, the portfolio is rebalanced to reflect a decreasing tolerance for portfolio volatility.

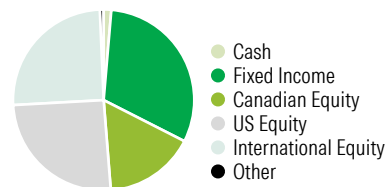

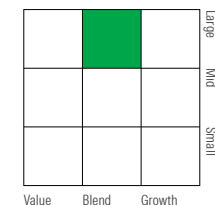
