Legal assistance

Talk to a team of experienced lawyers and notaries¹ for information on everyday legal matters. Tax and criminal law not included.

For example:

- Property law (condo ownership, issues with neighbours, easements, etc.)
- Family law (marriage, divorce, shared custody, common-law relationships, etc.)
- Labour law (work contracts and relationships, accidents, termination, etc.)
- Real estate law (hidden defects, buying and selling, renovations, etc.)

Autonomy assistance

Travel assistance
