During this meeting, members will be asked to:

1. Approve the minutes from the special general meeting about the amalgamation agreement.
2. Review the audited financial statements for the fiscal year ending December 31, 2018, and the reports submitted by the auditor and the Audit Committee, in addition to any other information on the credit union's financial situation. Copies of the reports will be available at the AGM and at the caisse offices 10 days before the meeting.
3. Appoint an auditor for the credit union and for Caisse Desjardins Ontario Credit Union Inc. for 2020.
4. Elect credit union board members.
5. Determine the amount to be allocated to the Community Development Fund.
6. Discuss any other matters under the mandate of the AGM.

Credit union members and shareholders will vote on **special resolutions** to modify the credit union's articles to allow the credit union to redeem Class A preferred shares at any time
